- b. Brian shared that Scott Walker was in favor of the proposed MBDD TIF request in the current state and the proposed list of properties

VIII. Director Report

- a. Adams and Reese Update
 - i. Tiffany T updated the board on the upcoming tasks regarding the TIF request.
 - ii. The goal is to get the item introduced on the 10/21/21 agenda but it may be too late. There is a chance it could be introduced from the floor.
 - iii. The MBDD board is in favor of making sure the item is on the 11/10/21 agenda which would only leave the 12/15/21 meeting for adoption.
 - iv. The MBDD and District 5 would like to capture the 2020 tax baseline so getting this approved before the end of 2021 is a priority.
- b. Dana Brown Update
 - i. Dana Brown was on the zoom to update the board on next steps for the project.



- ii. Dana's firm will be setting up a public programming meeting at the park hopefully in early November. Goal to start putting a list of programming activities.
- iii. Dana will send the board the informational flyer when ready.
- iv. Dana also sent the board a tentative timeline for all tasks which would meet the Chairman's request to have a working document and plan by December.
 - 1. 3 options for the plan will be presented and then sketches will be completed
 - 2. Tentative date is December 16, 2021
- c. Core Construction Update
 - i. Core has selected the architect firm Rome Office.
 - ii. In the coming weeks, there will be meetings for all stakeholders to give input and help the project start to get a sense of purpose and design.
- d. Severn Ave Project Update
 - i. From Matthew Zeringue, Parish Project Manager

Command finally has some extra crews on site this week.

- A majority of all roadway paving should be completed over the next 2 to 3 weeks.
- A few small sections will be completed in early November.
- It does not look like all of the sidewalk pavers will be completed by Thanksgiving.
- During the holiday season, contractor will not be allowed to close any intersections or side streets.
- At a minimum travel lanes will be open during afternoon/evening hours as well as weekends.
- We are currently discussing specifics on what can be allowed with the remaining work during holiday season.
